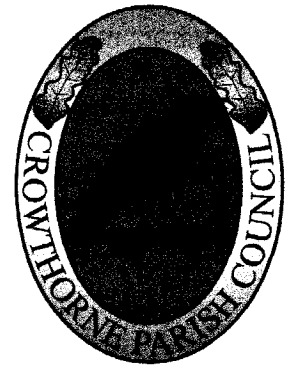



Footnote 1

The following are a "relevant person":-

- (i) your spouse or civil partner
- (ii) a person with whom you are living as husband and wife or as if you are civil partners.

Footnote 2

"body in which you/a relevant person has a beneficial interest" means a firm in which you/the relevant person is a partner or a body corporate of which you/the relevant person is a Director, or in the securities of which you/the relevant person has a beneficial interest. "Director" includes a member of the committee or management of an industrial and provident society.

Footnote 3

"Securities" means shares, debentures, debenture, stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited within a building society.
